UPGRADE TO MICROSOFT® SQL SERVER 2019 EXPRESS

Case Notebook suite was upgraded from Microsoft® SQL Server 2014 Service Pack 3 (SP3) Express to Microsoft® SQL Server 2019 Express, which is a more powerful, reliable, and modern SQL solution.

The following enhancements were made in Case Notebook Administration to support this upgrade:

- SQL Server 2019 is supported only on 64-bit platforms, therefore an easy-to-use repository migration tool is available for users with an existing 32-bit SQL Server repository instance.
- Case Notebook automatically detects if the users' current repository resides on a SQL Server instance that is outdated.
- Upon login to Case Notebook Administration, users that are running the application on an outdated SQL Server instance are prompted to upgrade their repository to the current version of SQL Server for improved security and performance. Users have the option to start the migration process immediately, or do it later at their convenience. If they choose to proceed, a step-by-step wizard guides them through the migration process. Once the repository migration is complete, they are presented with an option to perform case migration immediately or later. For users that choose to perform the repository migration at a later time, a new menu item, Migrate Repository, is available in the existing list of options under the Repository menu.
- Users have the ability to perform case migration from a new menu item, Migrate, which is available in the existing list of options under the Case menu.
- Users have the ability to export cases in their entirety from a new menu item, Export, which is available in the existing list of options under the Case menu.
- A new file type, Cabinet files (.cab), was added to the list of existing file types which can be imported from the Case > Batch Import menu item which gives users the ability to import cases in their entirety.

Note: Users have the option to install Microsoft® SQL Server 2019 Express with the Repository. If they choose not to install Microsoft® SQL Server 2019 Express, then they can install Case Notebook Administration (NoSQL), and attach Case Notebook Administration to an existing repository (in Case Notebook Administration, close any open repositories, select the 'Repository' menu and then select 'Install SQL Server Repository').

The following enhancements were made in Case Notebook to support this upgrade:

- Once the repository migration is complete, upon login to Case Notebook, users are presented with a 'Repository Update Check' dialog box to inform them that the repositories in their list may be out of date.
- Users can click 'Yes' to check for updated repositories immediately. If users click 'No,' the dialog box is presented again at the next login, unless the 'Don't show me again' check box was selected previously.

COMPATIBILITY WITH MICROSOFT® SQL SERVER 2022

Case Notebook and Case Notebook Administration are now fully compatible with Microsoft SQL Server 2022 as part of our commitment to seamlessly integrate cutting-edge innovation across performance, security, and availability.

UPGRADE TO OPEN SSL (OPEN SECURE SOCKETS LAYER) 3.0.0 WITH TLS (TRANSPORT LAYER SECURITY) 1.2 ENABLED BY DEFAULT

Open SSL (Open Secure Sockets Layer) is a widely used set of encryption tools that provides secure communications using Transport Layer Security (TLS) and Secure Sockets Layer (SSL) protocols over the internet. The Case Notebook suite was upgraded to use Open SSL 3.0.0, which is the newest supported version of this security library, with TLS 1.2 enabled by default.

UPGRADED OCR (OPTICAL CHARACTER RECOGNITION) ENGINE IN CASE NOTEBOOK

Optical Character Recognition, or OCR, is a technology that enables you to convert different types of documents, such as scanned paper documents, PDF files or images captured by a digital camera into editable and searchable data. Case Notebook utilizes world leading OCR technology from ABBYY, which has now been upgraded to the newest version to provide enhanced performance to users.

MODIFIED PERMISSIONS IN MANAGED CASES FOR EXTERNAL AND READER USERS

External and Reader users will no longer have the ability to create, edit, or delete data groups and content items in data groups. In addition, the Create New Case button will be disabled in managed cases for External users. As a result, External users will not have the ability to create a new case when they are accessing a managed case.

CLARITY IN THE MESSAGE REGARDING ENABLING ACTIVE DIRECTORY AUTHENTICATION

Case Notebook Admin users who attempt to reach the Active Directory service with their local credentials will be shown a clear message to inform them that the Active Directory service cannot be reached if they log in as a local user (with their local credentials). They must log in as a domain user in order to reach the Active Directory service and enable Active Directory authentication.

Obtain transcripts via email from a court reporting agency in PTX or PTZ file format with enhanced security and import those files into Case Notebook without any additional steps.
