Alabama

The following Alabama Police Jurisdictions had the rates removed - they are now 0.000%.

The following explanation is given by the state:

"The below listed municipalities failed to file an annual report required by §11-51-91(c), Ala. Code 1975. Therefore, all municipalities listed below are statutorily prohibited from collecting any license revenue, taxes, or fees in their respective police jurisdictions. This prohibition is effective as of June 1, 2023, which is 60 days from the date the Alabama Department of Revenue was provided notice of the rate change due to the failure to file the annual report."

South Carolina

Newly added deductions "Over 90-day Stay" and "Sales Paid to DMV (IMF)" will erroneously populate in the XML for all jurisdictions if entered for any jurisdiction in the ST-3 Multiple Locations Return.

CLOSED ISSUES

South Carolina

The ST-3/ST-455 Multiple Locations Return will now print the ST-389 page 6 worksheet for Green Space Tax for applicable counties.

Deduction codes and names for the ST-3 Single and Multiple Locations Returns will now generate correctly in the XML file and will no longer cause a rejection from the state.
