Alabama

The following districts had tax rate changes:

- Town of Madrid imposed a Rental rate of 4.000%
- Town of Madrid Impose an Auto Rental rate of 1.500%
- Town of Orrville increased their General Sales rate from 3.500% to 4.500%
- Town of Orrville decreased their General Use rate from 3.500% to 2.000%
- Town of Skyline increased the manufacturing Equipment Sales rate from 0.050% to 2.500%
- Town of Skyline increased the Auto Sales rate from 0.050% to 1.500%

The following districts changed administration:

Arkansas

The city of Banks enacted a 1.000% sales and use tax rate.

The city of Brinkley decreased the sales and use tax rate from 3.000% to 2.000%.

The county of Crawford decreased the sales and use tax rate from 1.250% to 0.250%.

California

The partial exemption for Dyed Diesel sales and Diesel sales was sunsetted for all Sales and Use forms.

Georgia

The rate of the Prepaid Wireless E911 Surcharge increased from 7.000% to 9.000%.

APPLICATION UPDATES

Internal Response Compression

We compressed the output response returned by passing `gzip` compression value as header resulting in an improved performance across the application.

Updated Batch Prepayment Logging

We improved the initial prepayments logging in batch jobs to enhance efficiency and performance.

OPEN ISSUES

Alabama

For Fairfield, Food tax types come in as the Town of Butler. Also, Consumers Use Food and Sellers Use Food tax types won't work for Butler if Fairfield is also in the binder. If Fairfield is in the binder with the Town of Butler, the Town of Butler will tax Consumers Use Food tax type and Sellers Use Food tax type at 3.500% instead of 3.000%.

Kansas

Newly-added district Atchison B&M Freight Depot CID populates with the wrong tax code for non-food tax types. It currently populates with "ATTC3" instead of "ATCC3."

Texas

Newly-added special purpose district Kaufman County Emergency Services District No. 7 5129578 mapping isn't correct and won't be transferred into the tax forms.

Newly-added special purpose district Wise County Emergency Services District No. 2 5249528 mapping isn't correct and won't be transferred into the tax forms.

CLOSED ISSUES

Fixed US Tax Summary Extract Report

Two additional columns were appearing in this report. This issue is fixed now in ONESOURCE Determination. The template defined in ONESOURCE Sales and Use Tax Compliance should work correctly now when you use this report.
