
APPLYING TAX LAW UPDATES

To apply a tax law update, complete the following steps.

1 Within the **Calendar Setup** module, select **Tax Law Update**, then select **Event Templates**. The **Pending Event Templates** window opens and displays a grid of any tax law updates that have not been processed.
