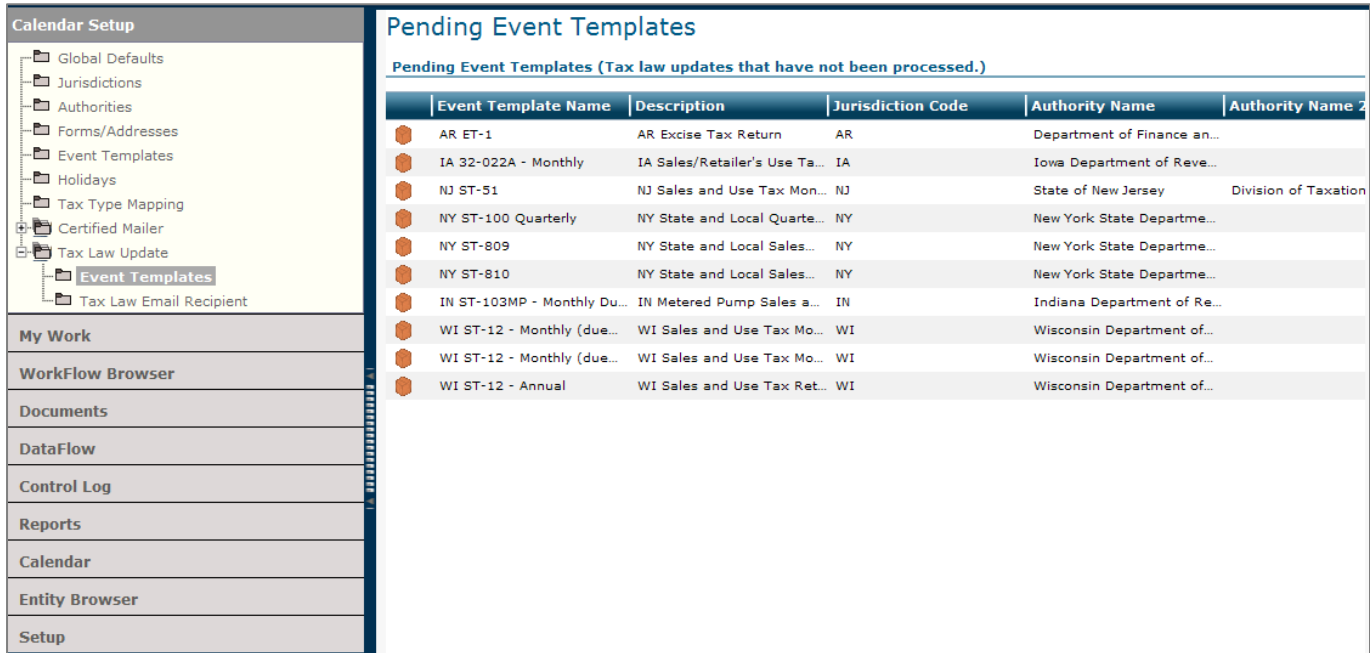
REQUESTING NEW OR UPDATED CONTENT

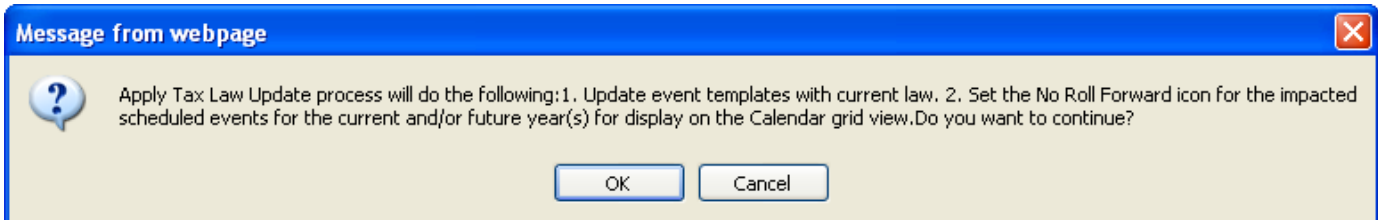

- 2 Select an event template name, then select **Apply Tax Law Update** from the **Actions** menu. - 3 Click **OK** to continue. The selected event template name is removed from the Pending Event Templates grid.
