Introduction

On 8 September 2016, the Egyptian president has ratified the new Value Added Tax (VAT) Law and it has been published in the Egyptian official journal.

Egypt's ministry of finance proposed the VAT draft law on 20 May 2016, and it received the parliamentary approval on 28 August 2016.

The President has announced that the Sales Tax regime will remain in effect until the Executive Regulations are released by the Minister of Finance. Article Eight of the VAT Law allows 30 days for these regulations to be issued after the effective date of the law. Article Nine provides that the law becomes effective on 9 September 2016, the day following publication.

The authority of Egypt VAT has been added, including all rates, catch-all rules, and cross-border logic in response to the above mentioned legislation.

The authority of Egypt VAT has been shipped to customers "Turned Off" to allow for a smooth transitional period from Sales Tax to VAT.
