Introduction

In our November Content Update #1 we added 18 city level authorities and 11 departmental level authorities to support the Occupancy Tax for furnished accommodations without classification in France. In this December #1 Content Update we have added an extra city level authority for the city of Ajaccio, including all rates, catch-all rules, and product taxability. This guide reflects all the changes relating to the Occupancy Tax in France that have been included in our November #1 and December #1 Content Update. Subsequent updates will include the remaining authorities required to support the Occupancy Tax throughout France.

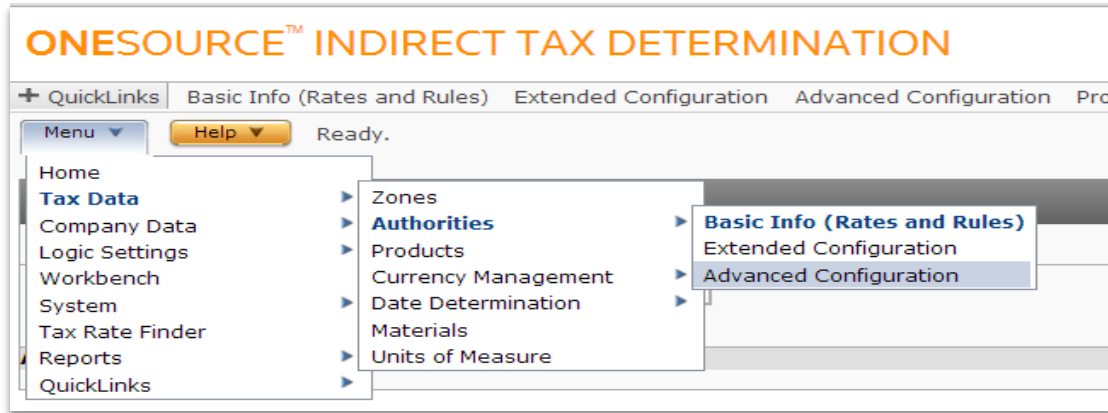

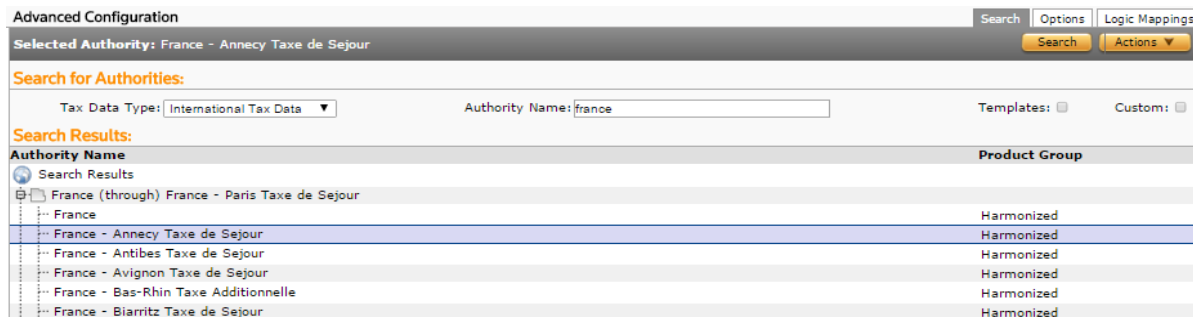
PART II – USING THE AUTHORITIES

Turning On the authorities

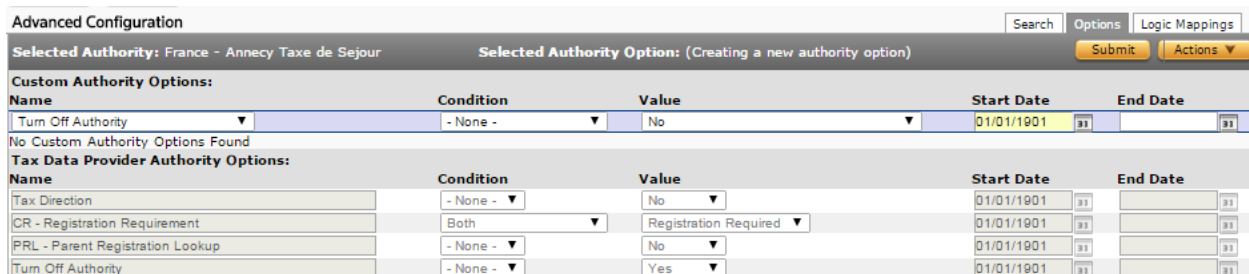
The hotel authorities are turned off by default. To turn it on, select Tax Data, then Authorities, then Advanced Configuration.



On the Advanced Configuration screen, select search for the hotel authority and select it.



Select the Options tab and then click the Actions button and select Add from the drop-down menu. Select the name of the option “Turn Off Authority” and set the condition to “None”, the value to “No” and the start date of 01/01/1901. The image below shows the selections.
