Introduction

The authority of Ireland Domestic Reverse Charge has been added to ONESOURCE Determination, including rates, catch-all rules and cross-border logic. It has been created in accordance with the Ireland VAT Act to account for Domestic Reverse Charge on the sale of some of the specific products listed in Section 16 of the referred legislation.

The reverse charge for the specific Goods will be driven by the establishment of the buyer in the Ship From location. Therefore, in order to trigger the Domestic Reverse Charge authority, it is necessary to set the establishment of the buyer in the Ship From location to "Yes".

As for the specific Services products, the Domestic Reverse Charge authority will require Physical Performance or Customer Location Services transaction type and will be triggered by the Tax Code of "DRC".

Turning On the authority

The Ireland Domestic Reverse Charge authority is turned off by default. To turn it on, access Tax Data > Authorities > Advanced Configuration Menu.
