Introduction

Several changes have been made this month to the authority Malaysia Tax Free. These changes allow customers who are currently testing future-dated Malaysia GST transactions to access taxability for the tax free zones of Labuan and Langkawi beyond the Malaysia GST implementation date of 4/1/2015.

Authority Option Updates

Authority options for the authority Malaysia Tax Free have been updated so that the authority continues to function beyond the Malaysia GST implementation date of 4/1/2015.
