MOROCCO REVERSE CHARGE

JANUARY 2014 CONTENT UPDATE #2

Tax Research

INTRODUCTION

Effective 1 January 2014 Morocco requires a reverse charge on the import of services performed by a supplier that is not established in Morocco. The January 2014 Content Update includes changes to authority option settings to allow the reverse charge on imported services. This change will only be supported in versions of ONESOURCE Indirect Tax Determination versions 5.0.0.0 and above.

Note: After the January Update, domestic sales and purchases of services will require the establishment of the seller in the supply location. Figures 6 and 8 below show the tax results when the seller establishment is set to "Yes" for the supply location.

CONTENT UPDATES

The following authority option updates are included in this update.

AUTHORITY OPTIONS

Turning on the PP – Physical Performance Reverse Charge authority option allows for physical performance transactions to return results for sales from non-resident suppliers to resident purchasers. The authority option of PP- Physical Performance Reverse Charge has been updated as shown in Figures 1 and 2 below.

Tax Results: Services

Example 1

Prior to the January 2014 Update, a transaction with the following parameters would return a Severity 2 Error:

Seller Primary: Bolivia

Buyer Primary: Morocco

Supply: Morocco

Date of issue: 23 December 2013

Note: The supply parameter is critical for tax determination.
