## **ABOUT THIS UPDATE**

---

The December Content Update Number 1 for ONESOURCE Indirect Tax Determination contains updates to Canada Content. This summary includes all changes to Canada Content included in the 2023.12.1.CANADA.G/G and 2023.12.1.CANADA.G/G.2 files. Versions 5.5.0.0 and subsequent releases are supported by this update.

### **Important Note Regarding Content Update Versions**

In Determination 5.7.0.0, we added tables and columns to the tax content database in support of Compliance and Allocated Charge functionality. Tax content data created for these features is not available to Determination versions 5.7.0.3 and prior. Thomson Reuters has therefore made the decision to produce two versions of tax content. Beginning with the March 2016 Content Update Number 1, the Content Update version that you download and import into your system depends on your currently installed version of Determination.

- If you are running Determination 5.7.0.3 or prior, you must use Compatibility Version G tax content.
- If you are running Determination 5.8.0.0 or a subsequent release, you must use Compatibility Version G.2 tax content.

## **AUTHORITY UPDATES**

The following updates are included in this month's Content Update unless otherwise noted:

### **British Columbia**

We added rules for freight and shipping charges in British Columbia that allow to correctly calculate tax applicable to each allocated charge line.

### **Environmental Handling Fees**

We updated the Environmental Handling Fees (EHF) applied to certain categories of batteries supported in the authorities of British Columbia Fees, Saskatchewan Fees, and Prince Edward Island Fees to reflect amendments that will come into effect on February 1, 2024.

Also, we revised Advance Disposal Fee in British Columbia on the Passenger Light Truck tire reporting category that will increase from \$5.00 to \$6.50 effective January 1, 2024.

### **Parent Registration Lookup**

We changed the value of "PRL - Parent Registration Lookup" authority option to "No" starting January 1, 2024 in the following HST authorities:

- New Brunswick
- Newfoundland
- Nova Scotia
- Ontario HST

As a result, these authorities will no longer be able to evaluate the registrations of other authorities that are attached to the same parent zone.

## APPLYING THE CONTENT UPDATE

The update process has two steps:

- Downloading the Update
- Installing the Update

### Downloading the Update

Use the Customer Center (<https://customercenter.sabrix.com/sabrixcc/>) to download monthly Content Updates:

1. Log on to the Customer Center using the username and password assigned to you by Customer Support.
2. Select the Platform onto which you will install this tax data. This is the ONESOURCE Indirect Tax Determination version you are running.
3. Select the **Currently Installed Version** of your content Sabrix INTL Tax Data based on your current version of Determination. For Determination version 5.7.0.3 or earlier, this is (2023.11.1.CANADA.G/G). For Determination version 5.8.0.0 and later, this is (2023.11.1.CANADA.G/G.2).
4. Select **Download** and save the file (2023.12.1.CANADA.G/G) or (2023.12.1.CANADA.G/G.2) to a directory on the system hosting the ONESOURCE Indirect Tax Determination application, or to a networked folder that can be accessed by that system.

### Installing the Update

To install the Content Update:

1. Log on to Determination.
2. Navigate to **Menu > System > Import/Export**.
3. Select the **Import** tab, and then select **Browse** to locate your file.
4. Select the content file you just downloaded.
5. Select **Open**.
6. Select **Import** when the pop-up window appears.
7. Select **Next** until the import starts.

You can close the window at any time—even before the import is complete. The results of the import are displayed in the **History** tab. Remember: you must import each Content Update in the correct order (date and version).
