Introduction

This guide provides an explanation of the most recent changes made to Determination for the implementation of the new content supporting Provincial Sales Tax on services transactions in Pakistan through the following authorities:

- Punjab Provincial Sales Tax
- Sindh Provincial Sales Tax
- Balochistan Provincial Sales Tax
- Khyber Pakhtunkhwa Provincial Sales Tax
- Islamabad Provincial Sales Tax

ONESOURCE Determination version 5.13.10 provides the functionality required to support the transactions involving provinces of Pakistan dated from 1 May 2023 onwards.

PART I – UPDATES TO DETERMINATION

Logic Mappings

In order to disable services transactions on country level in Pakistan, the authority logic group of Pakistan_Country_JD was added and mapped effective 1 May 2023 in the following authorities: Pakistan, Pakistan Additional Tax, Pakistan Manufacturer Additional Tax.

In order to enable services transactions and disable goods transactions on provincial level in Pakistan, the authority logic groups of Pakistan_Provincial_Tax_JD and Islamabad Provincial Sales Tax were mapped effective 1 May 2023 in the newly added provincial authorities, respectively.

The following authority options were added effective 1 May 2023 in the newly added provincial authorities:
