Introduction

The authority of Saudi Arabia has been added to ONESOURCE Determination, including rates, catch-all rules and cross-border logic. It is created in accordance with Saudi Arabia VAT Act and VAT Implementing Regulations to account for importing, exporting, manufacturing and consumption of goods and services.

Product taxability has been added to the authority of Saudi Arabia based on information available at the moment. The product taxability will be updated in the future once the Ministry of Health issues the list of medicines and medical goods subject to zero rate.

The authority has been added as "turned off" until the 31st of December 2017 and as "turned on" from the 1st January 2018.
