### Introduction

Several province level authorities have been added to ONESOURCE Determination under the country zone of United Arab Emirates, including rates, catch-all rules and cross-border logic. The different authorities have been added to support the new VAT regime applicable in United Arab Emirates and they have been created in accordance with the United Arab Emirates VAT Act to account for importing, exporting, manufacturing, and consumption of goods and services.

It is important to bear in mind that the VAT Executive Regulations that will establish the details on the application of certain VAT rules have not been published yet. Once the Regulations are published Thomson Reuters might need to make changes to the logic applicable to the country and to other aspects, such as product taxability. We are keeping close track on this and will inform our clients of any future changes to the United Arab Emirates authorities due to the publication of the VAT Executive Regulations.

Other important issues to keep in mind regarding the new authorities are the following:

- The authorities have been added as "turned off" until the 31st of December 2017 and as "turned on" from the 1st January 2018.
- In order to trigger the right result it is necessary to pass a province level address element within the United Arab Emirates. If only a country level address element is passed in the system, no result will be returned.

However, in the case of United Arab Emirates, and based on the text of article 48 paragraph 1 of the VAT Law, the default result on this case should be a reverse charge with a tax type of "RC".
