Introduction

This guide provides an explanation of the most recent changes made to ONESOURCE Indirect Tax Determination, which are designed to implement the new United Kingdom Plastic Packaging Tax. This tax facilitates the calculation of the Plastic Packaging Tax within the United Kingdom.

The tax is applicable to the manufacturing and importation of plastic packaging that contains less than 30% recycled plastic. This applies whether the packaging is manufactured in or imported into the United Kingdom.

By default, the United Kingdom Plastic Tax authority is deactivated. To use it, you will need to activate it. This document outlines the system updates and provides instructions on how to utilize the United Kingdom Plastic Tax authority.

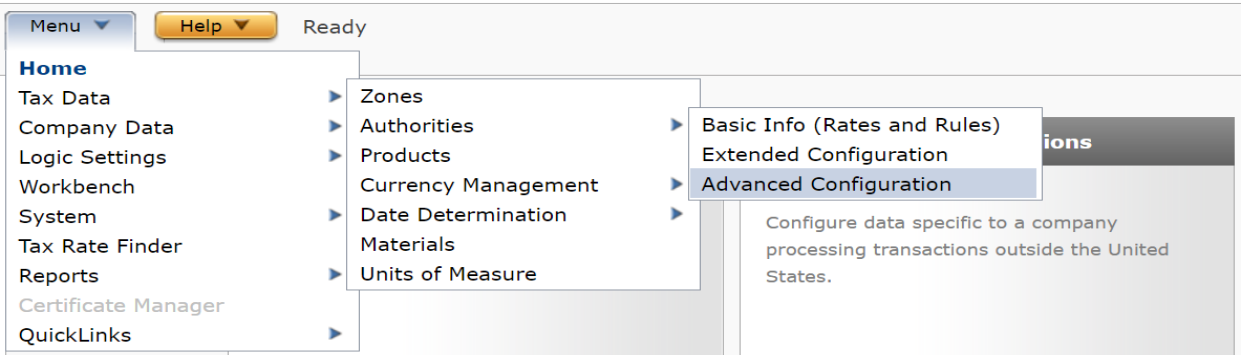

Turning On the Authority
