

**Initial Reminder for all transports:**

For upgrade customers transports should be imported with the “Overwrite Originals” check box selected when importing the transport. In cases where a customer has existing objects setup in their system and they import a newer transport which alters these objects an error is raised during the import if the “Overwrite Original” box is not checked.

**Basic Version 5.2.0.0.B Integration Upgrade Adjustments Prior to Transport:**

1. Some structures will change due to the transport, and fields put into these structures for a prior version of ONESOURCE Indirect Tax Integration may need to be removed. Pay special attention to any custom fields that you have put in these structures. These structures are:

1. Before processing the Enhanced Global Template Transport, make sure that the below list of fields are not in the structure **CI\_TAX\_INPUT\_USER** as they will conflict with the transport and cause an error. See below list.

3. Some structures will change due to the transport, and fields put into these structures for prior version of ONESOURCE Indirect Tax Integration need to be removed. These structures are:

4. This transport will have an effect on the FYTX0002 user exit. The include ZXFYTU03\_SABRIX will be overwritten by the transport but the matching logic in ZXFYTF01 and ZXFYTTOP will not be automatically upgraded by the transport. Make sure that none of the user exits, ie: (ZXFYTU03\_SABRIX, ZXFYTF01, ZXFYTTOP) contain any customer created custom code specific to your needs and environment. If so you may want to save a copy and re-apply any custom code changes.

Follow steps as shown below:

- Comment code /data declaration in ZXFY TU03\_SABRIX, ZXFY TF01 and ZXFY TT0P
- import transport number K9000180.DO2
- Manually insert includes ZXFY TF01\_sabrix and ZXFY TT0P\_sabrix respectively
- Merge any custom code/data declaration from ZXFY TF01 and ZXFY TT0P into new include programs.
- Also merge any customer code/data declaration from prior version of ZXFY TU03\_SABRIX. The version control may be helpful in managing the old and new versions.

5. Review this list of other includes for any customer custom code. The new transport delivers required code in ONESOURCE Indirect Tax includes, therefore you need to:

- Comment out the existing code in the following user exits and
- Replace it with the delivered includes as shown in the install guide.
- Merge any custom code/data declaration into new include programs.

6. New in this release is a correction to the credit/debit indicator. You may have work-arounds in place that will change due to this upgrade. Comment out or remove your Professional Services provided work-around solution/existing code that currently adjusts the credit/debit indicator. See class CL\_XTAX\_DOCUMENT method GET\_AUDIT\_DATA.

#### **ONESOURCE Indirect Tax Integration for SAP - Brazil template. K900184.DO2**

Fields required for the Brazil Template are included as part of the enhanced Global Template transport K900180.DO2. K900184.DO2 is an optional transport of additional Brazil template features and should not be added to your system if you do not need to calculate and collect Brazil tax.

Because this is a new optional feature and transport as of 5.2.0.0E release, there is not any adjustment requirements for this transport.
