

STATIC MAPPING

Instructions: This document cannot be referred for US. It's only recommended for Canada and EMEA Countries

This document provides mapping guidelines to create the custom “Tax Rate Code” based on your own requirements. There are some pre-requisites to follow before you start creating your own tax rate code.

There are two important things to look for:

1. XML elements mapping between Oracle and Determination fields.
2. Mandatory setups required in the OneSource Determination.

Please follow the mapping given below between the Oracle & Determination fields. You can see that which ‘Fusion Element’ is mapped with the ‘Determination field and the corresponding column name of the ‘tax configuration workbook’ is given where the value can be given.

In the 4th column of below table, there is a logic defined to derive the ‘required

Note: Please don’t modify any other fields on Tax Configuration workbook apart from this

SETUPS REQUIRED IN THE DETERMINATION

You need to create the “ERP Code Mapping” in the “OneSource Determination” to get the correct tax rate code from Determination.

NAVIGATION:

Go to Determination App home page → Configurations → Mapping → ERP Code Mapping

Step1: Click on the 'Add ERP Code Mapping'

Step2: Select the Company for which you want to create the mapping

Step3: Mapping group will be populated automatically as the default for the company.

Step4: Type will be Static

Step5: Give the Mapping Name


Step6: Mapping Priority – It specifies the order in which the mapping will be applied and evaluated. It will populate automatically, however if you want to change the order based on your requirements, you can do that.

Step7: ERP Code (For Static ERP Code Mapping, the value is applied to tax code in the results). Specify the ERP Code accordingly.

Step8: Based on the ERP Code in Step7, create the conditions accordingly.

Step9: Save it.
