VERSION 1.0.1.0

UPDATE SUMMARY

This is a maintenance release updating the prior 1.0.0.2 release.

The release 1.0.1.0 supports XSD changes made to Tax API by SAP Ariba. And also provides a temporary workaround for Invoice Reconciliation issue caused by repeated Tax Authorities in some US tax scenarios.

- SAP Ariba transitioning the Tax API in to ERP agnostic platform. As part of that SAP Ariba introduced new XSD elements called Organization Unit, Organization Name and Account Instructions. This release adapts to the SAP Ariba changes to support ONESOURCE customers.
- The repeated Tax Authority issue causes SAP Ariba Invoice Reconciliation to capture partial tax amount causing variance between taxes on SAP Ariba Purchase Order and Invoice documents. This release would provide a temporary workaround while SAP Ariba comes up with a permanent solution.

TECHNICAL CHANGES

DATA DEFINITION CHANGES FOR WEB SERVICES TAX INTEGRATION TASK

Issue: SAP ARIBA has upgraded Tax Web services XSD by introducing new elements. ONESOURCE Global Tax for SAP Ariba Solutions had to adapt the changes to facilitate tax calculation for SAP Ariba using new XSD.

Solution: ONESOURCE Global Tax for SAP Ariba Solutions adopted the XSD changes made by SAP Ariba. Organization Unit and Organization Name elements would be used instead of Company Code and UniqueName elements in SAP Ariba tax call request with new XSD.

ONESOURCE integration’s tax response would supply SAP Tax Account Key under AccountInstructions as expected by SAP Ariba new XSD.

Thomson Reuters ONESOURCE would support Customers with old XSD as long as SAP Ariba supports it.

REPEATED TAX AUTHORITY ISSUE FOR US TAX SCENARIOS

Issue: For some US tax scenarios there would be more than one tax authority at same jurisdiction level charging the tax on purchases. When Tax Authorities at same level (ex: District) is repeated, SAP Ariba Invoice Reconciliation would only considers tax amount from one tax authority ignoring tax amount from other authorities at that same level. Requisition captures tax from all authorities but Invoice Reconciliation does not. This is result in tax amount variance exception between Purchase Order and Invoice documents.

Solution: This release provides a workaround to fix the issue. ONESOURCE Global Tax for SAP Ariba Solutions would send repeated tax authorities with unique tax type so that SAP Ariba Tax API (Invoice Reconciliation) would consider tax from all repeated tax authorities.

This solution is offered as a feature toggle where it is turned on by default. Customers need to update tax master data in SAP Ariba Buying Solutions using Tax Type and Tax Type Mappings import tasks

UPDATE SUMMARY

This is a patch release updating the prior 1.0.0.1 release

The 1.0.0.2 release fixed the error in our Integration to return Tax Account Key as per SAP ECC's system's expected format. It has been returned as a two character (incomplete) key (ex: ES) which was causing integration issue during SAP Ariba's Payment Request processing in to SAP ECC as ECC expects it to be three character key (ex: ESE).

This release is targeted to fix this particular error. Now Customers can see ONESOURCE Global Tax for SAP ARIBA Solutions returning complete, Tax Account Key in SAP ECC's format.

Payment Request message or PaymentTaxExport.csv file in OK2PAY zip file in SAP Ariba Solution would show 3 character Tax Account Key under the column TAX_ACCOUNT_KEY

TECHNICAL CHANGES

INCOMPLETE TAX ACCOUNT KEY RECIVED IN TAX CALL RESPONSE

Issue: Integration is sending incomplete Tax Account Key to SAP Ariba Solution which causes Invoice integration issue between Customer's SAP Ariba Solution and SAP ECC systems.

Solution: Integration logic fixed to return complete Tax Account Key with three characters per SAP ECC's format.

UPDATE SUMMARY

ONESOURCE Global Tax for SAP Ariba Solutions 1.0.0.0 is new product added to the Thomson Reuters ONESOURCE family of ERP Integrations strengthening our cloud-based tax automation solution portfolio.

TECHNICAL CHANGES

NULL VALUES FOR CUSTOM FIELDS RESULT IN AN ERROR

Issue: For custom mappings when a NULL value was sent by SAP Ariba the integration raised an error.

Solution: NULL values are now processed without creating an error.
