UPDATE SUMMARY

ONESOURCE Global Tax SAP Ariba solution 2.0.2.7 is a maintenance release to enhance OSGTA 2.0.2.6 Solution and fix an error.

..FUNCTIONAL CHANGES

APPROVED ORDER DELETION MESSAGE ERROR

Issue: The One Source Global Tax for Ariba 2.0.2.6 integration system generates a warning message when Approved Order lines are completely deleted through “deletion” process on Ariba which truncates the deletion process through generation of a Null message response. This affects both V2 and v3

Solution: Enhance the OSGTA 2.0.2.6 integration message to enable completion of Order deletions successfully without truncation of the deletion process.

SCROLLING ON OSGTA INTEGRATION UI TRANSACTIONS PAGE

Issue: On OSGTA integration UI transaction ‘search results’ log page, the system scrolls to the last transaction on the page when users open the page instead of the latest transaction on the first line of the transaction log. To see the latest transaction, integration users are required to scroll through the transactions from the last line at end of page to the first line on top of the log.

Solution: Enhance OSGTA 2.0.2.6 v3 and v2 transaction log page to default to the first line of the “search results” transaction log for better user experience and product efficiency.

WRONG ERP POSTING CALL RESPONSE TO SOURCE SYSTEM REQUEST

Issue: OSGTA ERP tax response shows tax jurisdiction validation response only instead of ERP posting tax calculation response with all required posting details for integration and reconciliation of postings on ERP’s

Solution: Debug OSGTA 2.0.2.6 v3 to correctly generate and send all required ERP posting response for proper audit and reconciliation of tax transactions.
