An issue reported for report with Colorado Late Delivery Fee, the Total Tax Amount field includes Colorado RDF, but it does not equal the total of state, district, county, and city tax in the report. A fix been applied to the 'Line state tax amount' column in the US Document Detail report.

Other Vulnerabilities Found in Reporting (731823 and 351369)

- Fixed vulnerabilities by using cryptographic hashes for data stored outside the application code.
- Safeguards were put in place to prevent unsupported characters from being used in the company name.

Top Level Company Not Visible in Reporting (374692)

Fixed the issue where the top-level company was not visible in Reporting.

Reporting Attribute Prompts Not Working (502487)

Fixed the issue of Reporting attribute prompts to apply filters correctly.

Custom Attributes for Original Reporting (374739)

ONESOURCE Determination increased from 50 to 200 the number of attributes at both the invoice level and line level (an increment of 150 attributes at each level). System Security Update - Log4j Vulnerability in Reporting Server (511676)

While using SAP Data Services (DS) version 21 along with Reporting, an issue was reported with ETL jobs failing. This issue has been fixed in Reporting along with SAP identifying and addressing the vulnerabilities on their side in DS patch 21.

Issue Generating a Custom Report without Company Name as the First Parameter (374664)

There was an issue with generating a custom report in ONESOURCE Reporting that occurred if the company name was not passed or was not passed in the first parameter. This issue is resolved.

Enhancement in ETL for Other Language Characters (ACE-4791)

Reporting was enhanced to enable running ETL on other languages. Reporting is now capable of running ETL on Chinese, Russian and Japanese characters.

ADDRESSED ISSUES

Performance Issues for US Document Details Report (ACE-4866)

An issue with the **US Document Details Report** caused the report to fail to run when large volume of data was present. This issue is resolved and the report is now working as expected.

User Password Sync Issue (ACE-4872 and ACE-4904)

An issue was reported with syncing user passwords from Determination to Reporting when adding or updating user credentials. This issue is now fixed.

Exemption Certificate Report Issue with PST Authority Type (ACE-4870)

An issue with the **Exemption Certificate Report** caused certificates created in Determination with Canadian Authority types (such as PST) to be excluded from the report. This issue is now fixed.

Missing Information from US Tax Authority Details Report (ACE-4863)

An issue with the **US Tax Authority Details Report** caused the Quantity Amount, Gross Amount and Exempt Amount to be excluded from the report while these same fields were included in the **US Document Details Report**. This issue is now fixed.

Issue with Company Name Having Two Consecutive Spaces (ACE-4793)

Reporting failed to load reports if a company was created with a name that contained two consecutive spaces. This issue is now fixed.

Attribute Prompts Inconsistent Saving Behavior in Report Templates (ACE-4471)

An issue with editing attributes caused changes to save incorrectly after a report template was modified. The issue is now fixed. Saving this data is now consistent.

US Document Details Report - Tax Amount Inflated (ACE-4848)

In some cases, the data in the following columns of the **US Document Details Report** had inflated values listed for line level values:

- Line Taxable Amount
- Line Tax Amount
- Line Calculated Tax Rate
- Line State Tax Amount
- Line County Tax Amount
- Line City Tax Amount
- Line District Tax Amount

This issue is now fixed. The workaround for this was previously posted in the *Reporting 6.6.0.0: US Document Details line amounts inflated* knowledge base article.

Support for Oracle 19c (ACE-4785, ACE-4843, ACE-4844, ACE-4845, ACE-4819, ACE-4821, ACE-4847)

As part of ongoing platform support, Reporting now provides support for the Oracle Database 19c (19.6) Enterprise Edition.

SAP Business Objects Upgrade (ACE-4846)

Reporting 6.8 now depends on the following SAP Business Object components:

- Support for SAP BI Platform 4.2 sp8.
- Support for Data Services 4.2 sp14.

KNOWN ISSUES

This section contains several known issues and workarounds that you may encounter in using ONESOURCE Indirect Tax Reporting. This is not intended to be an exhaustive list of issues.

Chinese, Cyrillic Characters Enablement (ACE-4791)

Chinese or some other languages have the characters set to question marks during the ETL from audit to reports. There are workarounds available, but a solution is required to address this permanently.

Report Fails If Consecutive Spaces in Company Name (ACE-4793)

All reports fail with the error “Please sign out and try again” if the Company Name has two spaces within it.

Error Running Report Usage (ACE-3337)

In cases where a Transaction Extract report is copied using Save As, the Report Usage report will return the following error: Error in file Report Usage: Error in formula AccumulateValues: 'whileprintingrecords; ' String length is less than 0 or not an integer. Details: errorKind.

To work around this issue, avoid using Save As to create copies of Transaction Extract reports. If you run into the above error, contact Customer Support.

Transaction Extract in Custom Folders (ACE-3478)

Copies of the Transaction Extract report do not work if you save them into any folders other than the default *Global Reports & Analysis*. There is no workaround.

Italy Intra-EU Services in Intrastat Report (ACE-3487)

The Intrastat Reports include sales and purchase of goods but do not report on services in Italy. There is no workaround.

Trace Files Created During Installation (ACE-3670)

The Reporting installation generates trace files that contain the following error: Could not parse XML Error_IndexOutOfBoundsException---- Error code:-2147467259.

The files show up in the directory where you run the installation. An example file name is TraceLog_1372_2014_06_11_09_25_22_207_trace.glf.

You can ignore this error and the related trace files; they do not affect the installation.

US CD Extract Configuration File Upload (ACE-3699)

When using Internet Explorer 11 in Compatibility Mode, you cannot upload new configuration files on the US CD Extract report. The fields on the **Upload New Files** window disappear when you attempt to select them. This issue is related to group policy settings in Internet Explorer 11. This issue only occurs when using Internet Explorer 11 in Compatibility Mode.

Multiple workarounds are available:

- Deactivate Compatibility Mode in Internet Explorer 11.
- Use Google Chrome or Mozilla Firefox to upload the configuration files.

Character Replacement in PDF Output (ACE-3763)

In some cases, PDF output shows incorrect characters. For example, all instances of the letter B are replaced with the letter M.

We have not established a root cause for this behavior. In some cases, the issue was resolved by a full browser refresh or an update to Adobe Reader. As a workaround, you can select Excel or Comma Separated Values for your output format.

DOWNLOAD THE SOFTWARE

To download and install the software, get the *ONESOURCEIDTReporting_661x.zip* file from the Indirect Tax Customer Center:

1. Open the Indirect Tax Customer Center at <https://customercenter.sabrix.com/>.
2. Log on using the username and password provided by Customer Support.
3. Find Indirect Tax Reporting in the **Available Products** list, and verify that **Installed Version** is set to **None**.
4. Select **Download** for Indirect Tax Reporting.
5. Save the file.
6. Unzip the *ONESOURCEIDTReporting_661x.zip* file.
