The following identifies the disruption duration and reason across the deployments of ONESOURCE Determination Enterprise Cloud tax calculation APIs.

AMER: Amazon Web Services (AWS) – SOAP and REST Tax Calculation API

- January 8, 2026: 15 minutes of intermittent failures due to planned renewal of UUID certificates.
- November 18, 2025: 174 minutes of increased latency and tax calculation failures caused by an increased frequency of data retrieval in the Determination persistent layer.
- October 20, 2025: 102 minutes of REST Tax API failures due to a major AWS outage in US-EAST-1 that disrupted our authentication service for tax calculations.
- October 15, 2025: 4 minutes of SOAP Tax API intermittent failures caused by database change.
- October 6, 2025: 10 minutes of SOAP Tax API intermittent failures caused by high resource consumption of a core service.
- September 11, 2025: 11 minutes of intermittent failures caused by human error during a configuration update.
- September 10, 2025: 6 minutes of intermittent failures caused by configuration problem on a platform proxy server.
- September 9, 2025: 2 minutes of intermittent failures caused by high resource utilization.
- September 3, 2025: 5 minutes of intermittent failures caused by a configuration problem on a platform proxy server.
- August 4, 2025: 1 minute of increased latency caused by system resource depletion.
- July 9, 2025: 24 minutes of failure and increased latency caused by system resource utilization.
- April 9, 2025: 3 minutes of failure caused by cloud vendor security maintenance.
- February 26, 2025: 9 minutes of occasional calculation failure due to locked database table
- January 18, 2025: 75 minutes of intermittent failure caused by authentication issue

EMEA: Amazon Web Services (AWS) – SOAP and REST Tax Calculation API

- January 8, 2026: 20 minutes of intermittent failures due to planned renewal of UUID certificates.
- October 29, 2025: 20 minutes of REST Tax API intermittent failures caused by misconfiguration of environment and region-specific variables during deployment.
- October 25, 2025: 3 minutes of SOAP Tax API intermittent failures caused by system resource exhaustion.
- October 20, 2025: 102 minutes of REST Tax API failures due to a major AWS outage in US-EAST-1 that disrupted our authentication service for tax calculations.
- October 15, 2025: 4 minutes of SOAP Tax API intermittent failures caused by database change.
- September 10, 2025: 10 minutes of intermittent failures caused by configuration problem on a platform proxy server.
- August 13, 2025: 5 minutes of intermittent failure due to authentication issue
- March 11, 2025: 103 minutes of occasional calculation failure due to proxy server downtime
- February 26, 2025: 23 minutes of occasional calculation failure due to locked database table
- January 22, 2025: 12 minutes of intermittent failure due to token generation issue

AMER: Oracle Cloud Infrastructure – SOAP Tax Calculation API

- June 7, 2025: 1 minute of intermittent failure due to Oracle Cloud Infrastructure database maintenance. Vendor resolved the issue.
- Dec 29, 2024: 318 minutes of intermittent failure due to Oracle US East having an issue. Vendor resolved the issue.

AMER: Oracle Cloud Infrastructure – REST Tax Calculation API

- October 20, 2025: 174 minutes of REST Tax API failures due to a major AWS outage in US-EAST-1 that disrupted our authentication service for tax calculations.
- September 11, 2025: 9 minutes of intermittent failures caused by human error during a configuration update.
