New row added to the disclosure grid which in turns links to the report. Removed read-only protection from Description column and added Add/Delete rows button. Users can now re-write these descriptions according to their individual circumstances and add new items as required.
	Renamed Auditors Report folder	Removed ‘post June 2016’ from folder name so now reads ‘Independent Auditor’s Report on the Financial Statements’. Report folder ‘Independent Auditor’s Report on the Financial Statements pre June 2016’ set to never display.
	Renamed note folder ‘Funding for the academy trust’s educational operations’. New name: ‘Funding for the academy trust’s charitable activities’.	Renamed the note folder per the Model accounts.

	Removed 'EntityDescription' variable from text.	Removed variable 'EntityDescription' from paragraph and replaced it with the word 'academy' in following notes; - 'Staff > Severance payments' - 'Long-term commitments, including operating leases – academy > Operating leases' - 'Long-term commitments, including operating leases – academy > Long-term commitments (other contractual commitments)'
	Replaced "board of trustees" with wording variable 'GoverningBodyDescription'.	All instances of "board of Trustees" now uses a wording variable linking back to the 'Information on Governance and Internal Control' dialog.
